



STEEL DAYS BURNOUT CONTEST REQUIREMENTS, RULES, AND LIABILITY WAIVER

This document must be printed, signed, and presented when you check in at the event.

Requirements

- All participants are required to sign a liability waiver before participating in the event.
- Participants must be at least 18 years old and have a valid driver's license.
- All participants and vehicles shall have valid insurance.
- All vehicles must have four (4) wheels.
- No bald, corded, or badly worn tires will be allowed. NOTE: Racing slicks are allowed.
- Participating vehicles must pass a basic technical inspection for safety. All decisions of the technical inspector are final.
- Hub caps, beauty rings, or anything on the wheels of the participating vehicles that can come loose must be removed.

Rules

- Failure to comply with competition rules and official instructions can lead to disqualification, eviction, and long-term bans from the event / future events.

Vehicle Rules

- No passengers are allowed.
- Participating vehicles must have drive shaft loops if the bumper height is 25" or higher. Each drive shaft must have a minimum of 2 loops. If a participating vehicle has a shaft no longer than 24", 1 loop, properly centered, will suffice. Drive shaft loops must be rigidly mounted to frame rails or to the floor on both sides of the shaft. (Four Wheel Drive only.)
- Drive to the front wheels of participating vehicles must be disengaged. (Four Wheel Drive only.)
- All participating vehicles must be in good condition inside and out. No damaged or missing body parts. Participating vehicles must have street legal appearance and fender wells.
- All participating vehicles must be powered only by gasoline or diesel fuel.



- Open bed vehicles are prohibited from carrying unsecured items or debris in the bed of the vehicle.

Event Participation

- Seat belts/harness and helmet must be always worn by the driver at all times while the participating vehicle is in motion.
- Participants may not commence driving/burnouts until after receiving the signal to do so by the event's official.
- Participants will have 30-seconds to complete their burnout after being signaled to start by the event official.
- Only water will be permitted on the tires of participating vehicles, no other substances or chemicals allowed.
- Participating vehicles must be kept in control at all times. If there is excessive tire hop or drifting, the vehicle must be stopped.
- The driver must keep his/her legs and torso inside the participating vehicle at all times.
- The driver must halt the vehicle immediately upon any signal or directive to do so by an event official. Officials have the right to stop any vehicle at any time.
- Participants shall stop driving immediately if the vehicle impacts and displaces a safety barrier.
- Participants demonstrating an exhibition of speed, including the performance of burnouts, outside of the designated area will be subject to criminal penalties.

Winner Determination

- The winner will be determined by the announcer and influenced by the crowd applause/reactions.

IN CONSIDERATION of being permitted to compete, officiate, observe, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited, including but



not limited to the competition area and any hot pit area), the undersigned PARTICIPANT, for himself, his personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that PARTICIPANT has or will immediately upon entering any such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which PARTICIPANT enters and PARTICIPANT further agrees and warrants that, if at any time, PARTICIPANT is in or about RESTRICTED AREAS and PARTICIPANT feels anything to be unsafe, PARTICIPANT will immediately advise the officials of such and will leave the RESTRICTED AREA prior to the event.

2. PARTICIPANT HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO make any claim or demand, legal or otherwise, against officials, car owners, drivers, pit crews, rescue personnel, and any persons in any RESTRICTED AREA, promoter sponsors, advertisers, owners, the City of American Fork, the American Fork Chamber of Commerce, American Fork Fire and Rescue, American Fork Police Department, the Steel Days Committee, lessors and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, brokers, consultants and others who give recommendations, directions, or instructions, or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and for each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "Releasees", FROM ALL LIABILITY OF THE UNDERSIGNED, his personal representative, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OR INJURY OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. PARTICIPANT HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST INCLUDING BODILY INJURY, PROPERTY DAMAGE OR ATTORNEY FEES they may incur arising out of my presence or participation in the EVENT(S) whether caused by the NEGLIGENCE OF THE RELEASEES or otherwise.

4. PARTICIPANT HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROERTY DAMAGE arising out of or related to the EVENT(S) whether caused by the NEGLIGENCE OF THE RELEASEES or otherwise.

5. PARTICIPANT HEREBY acknowledges that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or



property damage. Each of the UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. PARTICIPANT HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreements extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and it intended to be as broad and inclusive as is permitted by the laws of the State of Utah and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

7. PARTICIPANT HEREBY consents to allow his/her picture(s) or likeness to appear in any official document, news release, sponsor advertisement, and/or television and radio coverage of the event and grant permission to use and/or publish photographic portraits or pictures, video tape, or film of me in which I may be included in whole, part, composite, or reproductions thereof in black and white and/or color or otherwise made through any media now known for art, advertising, trade, or any other similar lawful purposes whatsoever, including the publicity and promotion of this Event itself and/or Steel Days, excluding commercial use.

8. PARTICIPANT HEREBY acknowledges that he/she has read, understands, and agrees to comply with all Requirements and Rules for the Event.

9. PARTICIPANT HEREBY certifies that the information provided on the Entry Form is true and correct to the best of his/her belief.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT AND INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
